

PRIVACY POLICY

ISF International School Frankfurt Rhein-Main (“We”), adopt this policy about the privacy of Personal Data collected from users of our website www.isf.sabis.net.

We are committed to protecting and respecting your privacy. We would never disclose your personal data to third parties or use it for bulk mail lists or newsletters unless requested or accepted by you.

This policy (together with our Terms and Conditions) sets out the basis on which any personal data we collect from you, or that you choose to provide it to us, will be processed by us. Please read the following carefully to understand our views and practices regarding your personal data and how we treat it.

DEFINITIONS

Personal Data - Under the EU’s General Data Protection Regulation (GDPR) personal data is defined as: “any information relating to an identified or identifiable natural person ('data subject'); an identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data, an online identifier or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of that natural person”.

WHAT INFORMATION DO WE COLLECT?

We may collect and process the following data about you:

- **Information you give to us voluntarily.** This includes your name, phone number, and E-mail address when you fill up the “Request Information” form, the “Contact us” form, or the “Alumni Registry” form.
- **Information We collect automatically about you.** Our website uses Google Analytics. Google utilizes the data collected to track and examine the use of www.isf.sabis.net to prepare reports on its activities and share them with other Google services. Google may use the data collected to contextualize and personalize the ads of its own advertising network. Personal data collected: Cookie and Usage Data. Place of processing: USA.

WHAT DO WE USE THE INFORMATION FOR?

Any of the information we collect from you may be used in the following ways:

Information you submit under the "Contact Us" form, the "Request Information" form, and the "Alumni Registry" form, will be stored in our databases for one year only in an anonymized format and would be automatically deleted afterwards.

No automated or profiling-based decision making would be done. You may request that we stop sending you any marketing material by sending an E-mail to data-protection@sabis.net.

HOW DO WE PROTECT YOUR INFORMATION?

We take reasonable precautions to secure Personal Data against accidental or unlawful destruction or loss, alteration, unauthorized disclosure or access. These precautions include technical, physical and organizational security measures, that are appropriate with the sensitivity of the information, and that ensure its ongoing confidentiality, integrity and availability.

The security of your Personal Data is important to us and confirm that we will be using acceptable security measures and procedures to help ensuring the highest level of security.

VIEWING, EDITING, OR DELETION OF YOUR PERSONAL DATA
